Re: Proposed Dredging

Dear Bob:

This is to advise that Cedar Fair, L.P. grants approval to dredge a water channel along the east side of Cedar Point Road (a.k.a. the Willows Road) and across the rear of its property which fronts Cleveland Road in order to supply water to your property subject to the following:

- Barnes Nursery, at its expense, secures all required permits and approvals.
- Cedar Fair shall review and approve, in advance, specific plans for that dredging which affects Cedar Fair property.
- No spoils will be deposited on the shoreline of Cedar Point Road.
- The dredging will not undermine the shoreline of Cedar Point Road.
- There will be no interference with traffic on Cedar Point Road.
- Barnes Nursery will assume all expenses associated with the dredging.
- Barnes Nursery will be responsible for any damage that may occur to Cedar Fair property and/or will reimburse Cedar Fair for any expenses Cedar Fair may incur as a result of this dredging.

- Barnes Nursery assumes all liability for such dredging and agrees to hold Cedar Fair, L.P., its subsidiaries, partners and employees harmless from any and all claims, suits, actions or penalties which may arise from this dredging.
- This approval applies solely to the above described dredging and does not extend beyond the year 2000.



We have observed that several stakes have been placed on our property in the water along the "Willows Road." We assume they were placed there by Barnes Nursery. If this is the case and since you currently have no authorization to dredge on our property, we request the stakes be removed immediately.

In addition, it has come to our attention that Cedar Point's or Cedar Fair's name is possibly being utilized as one of the applicants in your request to regulatory agencies to secure a permit(s) for your dredging project. If this is the case, then we request that the use of our name as an applicant or co-applicant be withdrawn and/or discontinued immediately inasmuch as we gave no explicit approval to be a party to the permitting process.
