On January 30, 2006, Broadwater Energy LLC submitted for filing an Application for Authority to Site, Construct and Operate LNG Import Terminal Facilities. On that same day, Broadwater Pipeline LLC submitted for filing an Application for Certificates of Public Convenience and Necessity. On February 8, 2006, Broadwater Energy and Broadwater Pipeline submitted an electronic copy of the non-public versions of the filings.

Although the hard copies are complete, it has come to our attention that on at least some of the electronic versions, a difficulty is present in opening two electronic Critical Energy Infrastructure Information ("CEII") files, 312383-SHI-CAL-500 (Rev. 0) (7 pages) and 312383-SHI-DWG-500 (Rev. B) (4 pages). These are located in FERC accession number 20060130-4043, file numbers 7 and 8.


